# CITY OF WEST HAVEN, CT BOARD OF POLICE COMMISSIONERS

Minutes of the special meeting held Thursday, March 28, 2019

The special meeting of the West Haven Board of Police Commissioners was called to order at 6 p.m. by Chairman, Raymond Collins, III at Police Headquarters, 200 Saw Mill Road. All those present rose and recited the Pledge of Allegiance.

Commissioner Sweeney MOVED to accept the agenda as presented; SECONDED by Commissioner Butler. A voice vote was taken and the MOTION PASSED unanimously.

### 1. PUBLIC SESSION

## 1.1 Closure of Streets - Haven Project

After reviewing the diagram, Commissioner Sweeney MOVED to approve the plan for the closure of streets for the Haven Project; SECONDED by Commissioner Butler.

Deputy Chief Perno informed the Commissioners that the Fire Department will be conducting training there tomorrow. They will be closing Water Street at Elm Street and Main Street at First Avenue, allowing egress to Bayview.

Corporation Counsel Tiernan will be coordinating with Deputy Chief Perno on a date to close the streets permanently.

Commissioner Sweeney asked if the emergency services will be able to train there on future dates. Corporation Counsel Tiernan explained that they're receptive to allowing more non-invasive trainings. It will be available to us until they begin demolition.

A voice vote was taken and the MOTION PASSED unanimously.

## 1.2 Vehicle Policy

Commissioner Sweeney MOVED to discuss the proposed Vehicle Policy; SECONDED by Commissioner Butler.

Commissioner Sweeney noted that there are things in this proposed policy that need more consideration, and he would like a few days to look it over.

In discussion, the Commissioners noted that the policy doesn't mention the Chiefs, nor does it explain what happens if someone is out on the long term for illness, workers comp, injury, etc. Additionally, "long term" needs to be defined, whether it be 5 days, 7 days, a month, 3 months, a year. They want to ensure that the vehicle is available if needed, and want to ensure that the City isn't liable for anything that may occur with the City car when someone is out on extended leave.

Commissioner Sweeney MOVED to TABLE; SECONDED by Commissioner Butler. A voice vote was taken and the MOTION PASSED unanimously.
