

**March 29, 2021  
(6:30 Special Meeting)**

A Special Meeting of the West Haven City Council was held on Monday, March 29, 2021 via remote methods in accordance with City Council rule #30.

Present were Council Members: Quagliani, Conlon, Donovan, Hoskie, Galignano, O'Connor, Johnston, Hamilton, Massaro, Cohen, McGee, Fanelli and Bruneau. Mayor Nancy R. Rossi was also present.

After the Pledge of Allegiance, the Special Meeting was called to order at 7:01 P.M. by Chairman Quagliani.

The Clerk of the Council read the call of the Special Meeting:

The purpose of this Special Meeting is as follows:

- Deliberations/Actions on a line-item transfer for the City Clerk's Office and extension of the Outdoor Dining Permit Fees/process.

Councilwoman Hoskie presented the following MOTION for consideration to the City Council: The City Council of the City of West Haven hereby approves the following inter-department line-item transfers:

<u>Line Item 11250010-51000 Regular Wages</u>	<u>Decrease \$2,000</u>
<u>Line Item 11250010-52770 Other Contractual Services</u>	<u>Decrease \$18,000</u>
<u>Line Item 11250010-52480 Other Professional Services</u>	<u>Increase \$20,000</u>

The MOTION was moved by Councilman Galignano and SECONDED by Councilwoman Fanelli and APPROVED unanimously viva-voice after discussion.

Councilwoman Hoskie presented the following MOTION for consideration to the City Council: The City Council of the City of West Haven hereby suspends the

Outdoor Food Dining permit fees in accordance with the COVID-19 pandemic restrictions. This order will take effect March 29th 2021, and expire June 30, 2021.

The MOTION was moved by Councilwoman Hamilton and SECONDED by Councilman Bruneau. Chairman Quagliani presented an AMENDMENT to set the expiration to November 1<sup>st</sup> 2021 which was SECONDED by Donovan and APPROVED unanimously viva-voice. Councilwoman Hoskie restated the MOTION-AS-AMENDED: The City Council of the City of West Haven hereby suspends the Outdoor Food Dining permit fees in accordance with the COVID-19 pandemic restrictions. This order will take effect March 29th 2021, and expire November 1st 2021. The MOTION-AS-AMENDED was APPROVED unanimously by the City Council viva-voice.

Council Member Massaro presented a MOTION to adjourn seconded by Council Member Donovan and APPROVED unanimously viva-voice.
