Chairman Massaro called the meeting to order at 5:08 p.m.

Councilman Gallignano made a **MOTION to APPROVE** following changes to the FY 2022- 2023 budget which was **SECONDED** by Councilwoman Hamilton. All in favor. Motion passed **UNANIMOUSLY**

Councilman Borrás made a **MOTION to APPROVE** the following Resolution which was **SECONDED** by Councilwoman O'Connor. All in favor. Motion passed **UNANIMOUSLY**

**RESOLVED:** The City Council of the City of Haven authorizes the amended, adopted Fiscal 2022-2023 City Expenditures and capital non-recurring of \$168,316,116 and sets the mill rate at 34.00 mills, Allingtown Fire Department expenditures of \$9,183,313 and sets the mill rate at 11.61 mills, Sewer expenditures of \$12,498,222 with sewer use fee of \$453 and car tax of 29.46 mills.

Chairman Massaro asked for nominations for Democrat Council member to be on the MARB Tier IV Board. Councilman Donovan made a **MOTION** to nominate Councilman Gallignano which was **SECONDED** by Councilman Bruneau. No other nominations were put forth. Nominations were closed. Motion was passed by majority with Councilwoman Garthwait abstaining.
