## **Board of Police Commissioners**

Minutes of the meeting held Tuesday, August 3, 2021

The regular meeting of the West Haven Board of Police Commissioners was called to order at 7:00 PM by Chairman Raymond Collins III at West Haven Police Headquarters, 20 Sawming Road. All those present, rose and recited the Pledge of Allegiance.

## Agenda

Commissioner Wright introduced item 9.1 to the pension portion of the agenda that formalized the approval for Master Patrol Officer Costanzo's disability. She also introduced item 9.2 to the agenda regarding a report from David Moran. Commissioner Carrano MOVED to add the items to the agenda; SECONDED by Commissioner Butler. Motion carried unanimously.

Chief Perno MOVED to accept the agenda as amended; SECONDED by Commissioner Carrano. Motion carried unanimously.

#### 8. New Business

8.1 Life Saving Awards – Sgt. Jeremy Meurice, Ofc. Jeffrey Nielsen, Ofc. Brandon Butler, MPO Louis Matteo, Ofc. Jeffrey Knuth, Ofc. Christina Parillo, Sgt. Jonathan Healey, Ofc. Joseph Riehl

Deputy Flemming presented the awards and offered the following remarks:

### Sgt. Jonathan Healey

"While patrolling the boardwalk Sgt. Jonathan Healey observed a male run and jump into the water, then disappear from sight. Sgt. Healey went down to the shoreline and observed the male floating face down in the water. Sgt. Healey immediately entered the water and dragged the male to shore. Realizing the male was not breathing and had no pulse, Sgt. Healey performed CPR until the male began breathing again on his own. The male was then transported to the hospital and recovered fully.

Sgt. Jonathan Healey, in recognition of your alertness and quick action in this emergency situation, we are proud to present you with this Life Saving Award. Your initiative and dedication in the preservation of a human life is an inspiration to your brother and sister officers, as well as the citizens of our community."

## Ofc. Joseph Riehl

"While on patrol Ofc. Joseph Riehl came across a serious motor vehicle accident which left a vehicle with significant damage and smoking heavily from a fire. Upon exiting his vehicle Ofc. Riehl realized the smoking vehicle was occupied with an unresponsive operator. Ofc. Riehl attempted to open the vehicle door but was unable to do so, due to the extensive damage. He then reached in through the door window, cut the seatbelt and then pulled the unconscious operator out of the vehicle and dragged him to safety. As a result of his actions Ofc. Riehl had to be treated at the hospital for smoke inhalation."

"Ofc. Joseph Riehl, in recognition of your determination and courage in the face of significant danger we are proud to present you with this Life Saving Award. Your quick response and dedication in the preservation of a human life is an inspiration to your brother and sister officers, as well as the citizens of our community."

### Ofc. Jeffrey Knuth and Ofc. Christina Parillo

"Ofc. Jeffrey Knuth and Christina Parillo were dispatched to a complaint of a distressed swimmer in the water by the Veteran's Memorial. Upon his arrival Ofc. Knuth quickly observed the distressed male swimmer approximately 100 yards from shore, struggling to keep his head above water. Ofc. Knuth entered the water and swam to the male and assisted in keeping him afloat, to prevent him from drowning. Ofc. Knuth then began pulling the male towards the safety of shore while keeping the male's head above water. Ofc. Parillo upon her arrival immediately

entered the water and aided Ofc. Knuth in rescuing the distressed swimmer. Together they were able to safely get the male to shore.

Ofc. Jeffrey Knuth and Christina Parillo, in recognition of your courage and determination in the face of significant danger we are proud to present you with this Life Saving Award. Your initiative and dedication in the preservation of a human life is an inspiration to your brother and sister officers, as well as the citizens of our community."

### Sgt. Jeremy Meurice, Ofc. Jeffrey Nielsen, and Ofc. Brandon Butler

"Sgt. Jeremy Meurice, Ofc. Jeffrey Nielson and Ofc. Brandon Butler were dispatched to the area of 105 Knox St on several 911 calls of a disturbance with loud yelling. Upon their arrival they located an apartment where they could hear a female inside screaming and glass breaking. With no answer at the door and the potential for violence occurring inside, they forced entry into the apartment. Once inside they located a female victim on the floor who had been severely beaten, she was bleeding profusely, and there was blunt force trauma to her head and face that resulted in her eyes swelling shut. Ofc. Butler immediately evacuated the female from the apartment for her safety and to get her medical aid, while Sgt. Meurice and Nielson searched the apartment for other victims and the assailant. As they entered the dining room area they located an unconscious male victim laying in a pool of blood with severe lacerations and extreme blunt force trauma to his face and head. Standing over the male was the assailant and after a brief standoff they were able to take him into custody and get the male victim medical attention. Both victims were transported to the hospital with life threatening injuries but they would eventually recover. The assailant was arrested without incident and charged with Attempted Murder.

Sgt. Jeremy Meurice, Ofc. Jeffrey Nielson and Ofc. Brandon Butler, in recognition of your quick response, and courageous actions during a dangerous situation we are proud to present you all with this Life Saving Award. Your initiative and dedication in the apprehension of a violent assailant and the preservation of two lives is an inspiration to your brother and sister officers, as well as the citizens of our community."

#### Ofc. Louis Matteo

"While working in the Police Department Cell Block, Ofc. Louis Matteo was in the process of booking a male prisoner who was located in the holding cell. During the interview process the male prisoner laid down on the bench and became unresponsive. Ofc. Matteo walked over to the male and realized he had stopped breathing and had no pulse. Ofc. Matteo called for medical assistance and began CPR. Shortly after the male began breathing again and regained consciousness. He was then treated by the West Haven Fire Rescue and transported to the hospital.

Ofc. Louis Matteo, in recognition of your attention to detail and decisive action by providing medical attention to someone suffering a serious medical emergency, which resulted in the preservation of a human life, we are proud to present you with this Life Saving Award. Your initiative and dedication are an inspiration to your brother and sister officers, as well as the citizens of our community."

Chief Perno added that they had wanted to present the Life Saving Awards a long time ago, but as a result of the pandemic and other events, it had been delayed. He explained that it was a long time coming. He also stated how proud he was to have Ofc. Nielson back from deployment to the U.S. Army.

Commissioner Wright MOVED for a 5-minute recess; SECONDED by Deputy Chief Flemming. Motion carried unanimously.

The meeting resumed at 7:34 PM.

## 8.2 Resignation - Officer Robert Crowther

Deputy Chief Flemming stated that it would be effective July 5th.

Chief Perno MOVED to accept the resignation; SECONDED by Commissioner Carrano. Motion carried unanimously.

#### 8.3 Resignation - Officer Jay Kaufman

Deputy Chief Flemming stated that it would be effective August 10<sup>th</sup>.

Deputy Chief Flemming also offered the following remarks about Officer Robert Crowther and Officer Jay Kaufman:

"I would like to thank both Officers Robert Crowther and Jay Kaufman for their service to the West Haven Police Department and the citizens of our community. Ofc. Crowther came to us after serving over 25 years with the New Haven Police Department and 14 years with the Woodbridge PD. Ofc. Kaufman came to us after serving 25 years with the Branford PD. Both were highly respected Field Training Officers who shared their knowledge and 64 years of combined police experience with our new officers. They were liked and respected by the rank and file and their commitment to our agency and community will be missed.

Congratulations Gentlemen on your well-earned retirement, we wish you and your families happiness as you begin this next chapter in your lives."

Commissioner Butler MOVED to accept the resignation; SECONDED by Commissioner Wright. Motion carried unanimously.

### 8.4 WestFest – September 18 & 19, 2021

Commissioner Wright MOVED to accept the proposal for WestFest and waive the fee for the 50/50 raffle brought up during public input; SECONDED by Commissioner Carrano. Motion carried unanimously.

Chief Perno MOVED to accept the details of the Block Party; SECONDED by Commissioner Wright. Motion carried unanimously.

## 9.1 Formalizing the approval of MPO Costanzo's disability

Chief Perno MOVED to formalize the approval of MPO Costanzo's disability from last month; SECONDED by Commissioner Carrano. Motion carried unanimously.

## 9.2 Report from David Moran

David Moran from the Raymond James financial service firm gave an update on the funds for the fiscal year. He also congratulated Commissioner Butler on his new term and Commissioner Carrano on his appointment to the board.

Commissioner Wright mentioned that she and Mr. Moran at least once a year meet to go through the allocations and diversifications of everything going on so that she is comfortable with the information he is presenting and the decisions that he makes. She also thanked Mr. Moran and his staff for their prudence regarding the fund and for notifying and including the board about everything that goes on with any updates.
