Temporary Event Food Permit Fees

Effective July 1, 2018 per Public Act 17-93 all temporary events must be inspected and/or reviewed and approved by Director of Health.

Additional Food Service Fees:

CFPM violation fee

Failure to designate and/or maintain a CFPM approved by the Director of Health or agent within 60 days of the CFPM deficiency shall result in a \$50.00 fee in addition to suspension of the food establishment's license. An additional \$50.00 shall be assessed for each further 30 day period. Failure to pay fines within 5 working days shall be cause for suspension of license to operate.

Temporary event late fee

Any application received less than 10 business days prior to the event will be subject to a late fee of \$50.00.

Cancellation of temporary event without notifying Health Department (no show)
